SPECIAL MEETING OF BREVARD KENNEL CLUB

January 14, 2019

Attendees: Edna Corney, Kristin Halkovic, Maureen Finch, Marsha Dyal, Tami, Carolyn Pincheck, Linda Pincheck, Susan and Steve Thibodeaux, Tracy Eberhardt, Pam Hinton, Brenda Warner, Cassie Hinton.

Meeting was called to order at 7:49 p.m. by Edna Corney. In response to the proposed ordinance by Councilman Bryan Lober concerning banning the sale of dogs by pet stores unless the dogs come from a shelter or rescue organization. Hobby breeders would be limited to 20 puppies per year and allowed to sell them at retail outlets.

The purpose was to discuss the creation of bullet points and documented information to back up such to form packets which can be distributed to Councilmen in hopes of the proposed ordinance being defeated. AKC suggestion was that we should state we are concerned about the health and well being of animals and humans in Brevard County. BKC will make it clear that we are not against local shelters and have in fact supported them throughout the years and intend to continue to do so.

Susan Thibodeaux will work on tying documentation to PETA and HUSA as the concern is that Councilman Lober is using information from

their organizations in his statements and he should understand what exactly their positions are.

Tracy Eberhardt pointed out that if the shelter dogs are sold through pet stores the safeguards that are currently in place to protect the dog and find the right fit for a forever home would be nonexistent.

After much discussion of all the stories gleaned from various sites the decision was that we concentrate on local issues and reach out to a man who is a dog friendly republican whose family resides in Melbourne and ask for advice. Carol Pincheck suggested circulating a petition authored by Susan Thibodeaux.

Brenda Warner suggested that BKC invite Teresa from the Humane Society to attend the BKC February meeting and talk to club about her business plan which includes sixty employees and a future doggie day care to fund the Humane Society in Cocoa.

Edna closed the meeting by asking everyone to continue to look for documentation and to contact her with what is found. The BKC board will be discussing the same subject matter at their next meeting.



New AKC-recognized Breed: the Azawakh

The Azawakh (pronounced AH-ZA-WAHK) is a tall, slender Hound originating in West Africa that is lean, nimble, athletic, and renowned for its guarding instinct. Also known for its gentle, affectionate, and playful demeanor, it will vie in the Hound Group.

The Azawakh was introduced in the U.S. in the mid-1980s, with the first American litter whelped in 1987. All were red or fawn with white markings. Breed growth reached the point where this African native was introduced into AKC's Miscellaneous Class in 2011.

ARTICLE IV – THE CLUB YEAR, ANNUAL MEETING, ELECTIONS, NOMINATIONS

SECTION 1. Club year. The Club's fiscal year shall begin on the first day of May and end on the 30th day of April. The Club's official year shall begin immediately at the conclusion of the annual meeting and shall continue through the conclusion of the next annual meeting.

SECTION 2. Annual Meeting. The annual meeting shall be held in the month of April at which Officers and Directors for the ensuing year shall be elected by secret, written ballot from among those nominated in accordance with Section 4 of this Article, except that when there is only one candidate for any office or only three candidates for Director, the Secretary may be instructed to cast a single ballot for the uncontested Board position(s). They shall take office immediately upon the conclusion of the election and each retiring officer shall turn over to his successor in office all properties and records relating to that office within 30 days after the election.

SECTION 3. Elections. The nominated candidate receiving the greatest number of votes for each office shall be declared elected. The three nominated candidates for other positions on the Board who receive the greatest number of votes for such positions shall be declared elected.

SECTION 4. Nominations. No person may be candidate in a Club election who has not been nominated; all nominees must be members in good standing and may not hold an office or board position in another all-breed club during the year for which they are nominated. During the month of December, the Board shall select a Nominating Committee consisting of three members and two

alternates, not more than one of whom shall be a member of the Board. The Secretary shall immediately notify the committeemen and alternates of their selection. The Board shall name a Chairman for the Committee and it shall be his duty to call a committee meeting and report the results thereof to the Club Secretary on or before February first.

A. The Committee shall nominate one candidate for each office and three candidates for the three other positions on the Board, and after securing the consent of each person so nominated, shall immediately report their nominations to the Secretary in writing or electronically.

B. Upon receipt of the Nominating Committee's report, the Secretary shall before February 15th notify each member in writing (may include electronic communication for notification) of the candidates so nominated.

C. Additional nominations may be made at the March meeting by any member in attendance provided that the person so nominated does not decline when his name is proposed, and provided further that if the proposed candidate is not in attendance at this meeting, his proposer shall present to the Secretary a written statement from the proposed candidate signifying his willingness to be a candidate. No person may be a candidate for more than one position and the additional nominations which are provided for herein may be made only from among those members who have not accepted a nomination of the Nominating Committee.

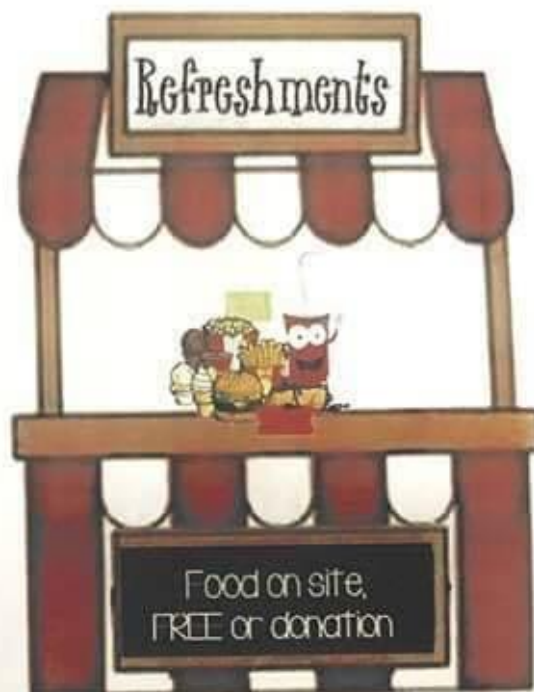
